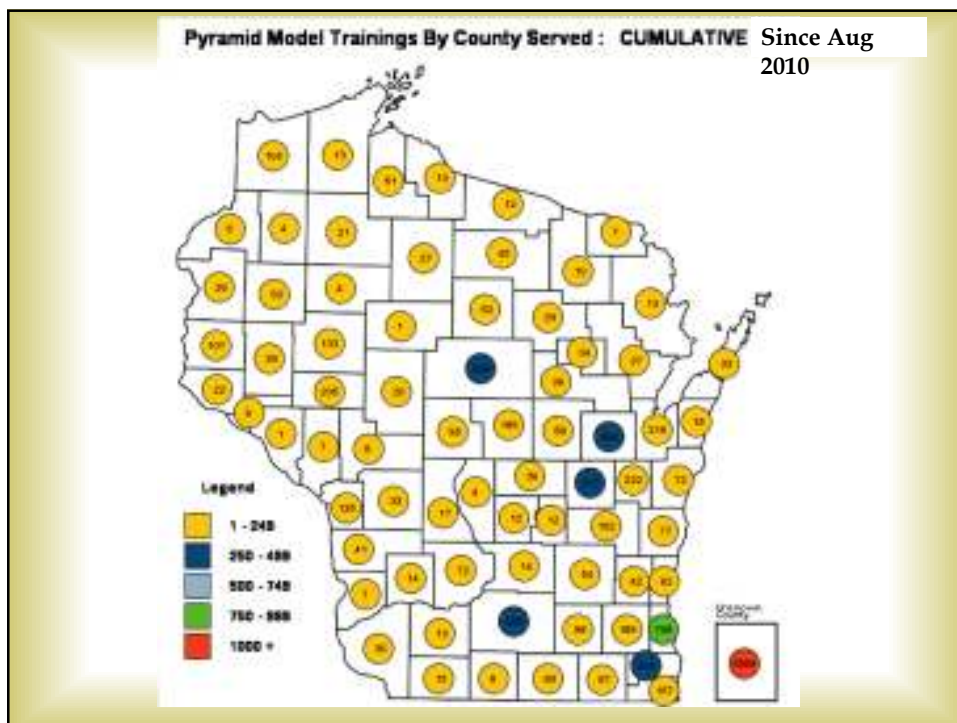


3 trainings reported since July data pull
